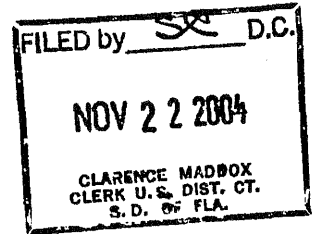

3. **Case Management** - The parties shall submit proposed case management and scheduling orders no later than December 8, 2004.
4. **Receiver's Communication** - The Court hereby vacates the order regarding the Receiver's communication (D.E. No. 448), filed on September 15, 2004. The Receiver is free to file reports with the Court at any time, provided he delivers a copy to all counsel and posts the report on the website for interested investors.
5. **Interpleader Actions** - Based on the report and recommendation and the supplemental report and recommendation, the Court invites the Receiver to file motions for judgment on the pleadings or motions for summary judgment no later than January 7, 2005 in all interpleader actions filed under this case number 04-60573-CIV-MORENO as well as in 04-60377-CIV-MORENO and 04-60836-CIV-MORENO.
