ALLEN NORTON & BLUE, P.A.'s FIRST REQUEST FOR INTERIM COMPENSATION TO PAY ATTORNEYS' FEES AND COSTS AND MEMORANDUM IN SUPPORT (May 6, 2004 through June 18, 2004)

Pursuant to Court Order, all objections to this Application must be filed and served within ten (10) days of this Application.

Rodolfo Gomez, a Shareholder of Allen Norton & Blue, P.A. ("AN&B") moves this Court to award interim attorneys' fees and costs incurred by AN&B as labor and employment

attorneys to the Receiver, Roberto Martínez (the "Receiver"), in support of this application, the undersigned submits the following:

- 1. Attached as Exhibit 1 is a summary of AN&B's fees and expenses incurred through June 18, 2004 ("the Application Period"). Exhibit "2" is a summary of all AN&B timekeepers, their billing rates and the total hours that were charged by each timekeeper in their representation of the Receiver through June 18, 2004 (the "Application Period").
- 2. Attached as Exhibit "3" is a summary of all expenses incurred by AN&B during the Application period.
- 3. The Receiver hired AN&B to advise him on the appropriate treatment of employees in a Receivership situation. AN&B has advised the Receiver and his counsel regarding several issues relating to the employment of the over 100 employees working at the Receivership Entities, including issues relating to employee termination, treatment of independent agents, COBRA benefits, 401 K plan and health benefits.
- 4. For the Application Period, AN&B seeks reimbursement for 44.05 hours of attorney time. The total amount of fees sought during the application period is \$10,493.75. Total expenses sought by AN&B for the application period are \$51.53. No prior applications for compensation have been filed and no compensation has been paid to AN&B.
- 5. I have carefully reviewed the attached exhibits and I am responsible for supervising all of the attorneys in my firm on the case. I certify that the hours expended and the

costs incurred were necessary and reasonable to represent the Receiver during the Application

Period.

MEMORANDUM OF LAW

When determining the award of attorneys' fees, the Court should give consideration to

the factors for compensation that the 11th Circuit articulated in In re Norman v. Housing

Authority of City of Montgomery, 836 F.2d 1292 (11th Cir. 1988), including (1) the time and

labor properly employed by the attorneys in processing the case; (2) the quality of services

rendered; (3) the scope of the activity; (3) the financial risk involved; (4) the complexity and

novelty of the issues involved; and (5) the beneficial results obtained.

AN&B respectfully suggests that its application meets all of the criteria for this interim

request for compensation. The Receiver, with the assistance of AN&B, has stabilized operations,

and effectively dealt with labor and employment issues and, to the extent possible, maintained

the status quo, with respect to employee compensation and benefits.

WHEREFORE, ALLEN, NORTON & BLUE, P.A., by and through the undersigned

counsel, respectfully requests that this Court enter an Order Authorizing the Payment of

\$10,493.75. in fees and reimbursement of \$53.15 in costs for the Application Period. A

proposed form of Order is attached.
